CONTRACT OF VOLUNTEERING – 19.08.2018

Article 1.

Volunteer will voluntary, free without an employment help children, and in house with instructions of professional staff and employed workers and with agreement with principal of house.

Article 2.

Before doing these activities or during the activities Organizer will provide to volunteer appropriate training and introduction with activities in the area of working with children with special needs.

Article 3.

Volunteer begins with volunteering from day 17.09.2018 until 13.10.2018. Volunteer weekly works 40 hours. At Saturday and Sunday volunteer does not work.

Article 4.

Place of volunteering is in polyclinic Zlatni cekin (Tjedni smještaj) or Kindergarten Cekin.

Article 5.

Volunteer commits to volunteer in accordance with professional regulations and ethical rules and instructions received by the organizer of volunteering. Without knowing or consent of principal or professional service, volunteer cannot give any informations to parent's relatives or any competent services. Also: Volunteer commits to keep official secret and also confidential and personal data of Organizer or any user of Volunteering.

Article 6.

Volunteer has next rights according to article 30. of Law of volunteering:

- written confirmation (contract) of volunteering, professional help, instruction and support,
- meeting the terms of volunteering, activities that will be performed by them, services that they will give and rights that they have based on Law and other regulations about volunteering,
- daily vacation in agreed duration and protection of privacy and personal data
- participation in decision related to volunteering according of opportunities of organizer.

Article 7.

A volunteer is required to execute the instructions of organizer, except the instructions that are morally unacceptable, dangerous or not in accordance with contract. If the execution of instructions can cause the damage to the volunteer, the users of volunteering or third person, the volunteer is obliged to warn the organizer. Volunteer does not response for the damage, if he warned previously the organizer to the possible danger. Responsibility for damage caused by he will of volunteer or volunteers inattention, is on the volunteer and organizer corresponds to the principale of objective responsibility.

Articel 8.

Serverance of the contract is regulated by article 29. of law of volunteering

Article 9.

With his signature, volunteer confirms that he has no criminal record, that against him are not submitted security measures and that against him does not lead any criminal proceeding.

Article 10.

Contracting parts confirm that they meet he rights and duties of the law of volunteeringand of this contract, and by their signatures, volunteers accepted the rights and duties.
